

PURCHASER TERMS AND CONDITIONS

Trade Promotion Lottery Name: **BERNINA 7 PRO “WIN A TRIP FOR 2 TO PARIS”**

1. Instructions on how to participate and the prize form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions. Offer not valid in conjunction with any other offer.
2. Entry is only open to Australian and New Zealand residents aged 18 years or over. Employees (and their immediate families) of the Promoter and agencies associated with this promotion are ineligible to enter.
3. The promotion is open to both Australia and New Zealand residents. All eligible entrants will have an equal opportunity to participate and win, regardless of their country of residence. Entry is limited to one per eligible purchase and registration of a BERNINA 7 PRO series machine.
4. The Promotion and Promotional Period both commence on **01/09/2025** and close at 11:59pm local time on **31/03/2026** (“Promotional Period”). Entries received outside of the Promotional Period will not be accepted by the Promoter and will be deemed to be invalid.
5. To be eligible to enter, individuals must purchase AND register a new BERNINA 7 Series PRO machine, including B 700 PRO, B 735 PRO, B 770QE PRO and B 790 PRO, from an authorised BERNINA retailer during the Promotional Period (“Qualifying Transaction”).
6. To enter, simply register your new machine by visiting bernina.com, click on ‘Product registration’ and follow the prompts to register your new 7 PRO Series sewing machine during the Promotional Period. All valid entries received during the Promotional Period will be entered into a draw. Each entry will be generated from the registration database of customers who have purchased a qualifying machine and submitted their registration details during the Promotional Period.
